1.1. Introduction

Safaricom is the leading integrated communication services provider in Kenya and has a steadily growing subscriber base of subscribers and enterprise clients. The company is continuously expanding and upgrading its systems and processes to meet the changing needs of its customers. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for supply of various goods and services.

To this end, Safaricom intends to engage services of reputable suppliers for the provision of **Provision of Main Switch Rooms and Data Centres Power Maintenance Services** for its network. The intention is to engage the suppliers in the power support and maintenance of the Safaricom Main Switch Rooms and Data Centres. Safaricom is therefore soliciting for Expressions of Interest (EOI) from interested qualified providers.

1.2. Background and EOI Requirements

Safaricom has rolled out a number Data Centres and Main Switch Rooms spread across Kenya to support its services offering. These sites require high capacity power which needs to be available without interruption. The provision of this power is done from various sources which require regular support and maintenance. To achieve this, Safaricom relies on contracted service providers who are engaged on a fixed term contract. The scope of the service offering is:

1. Preventive Maintenance
2. Corrective Maintenance
3. Facilities management and repair when needed
4. Upgrade works.

This EOI is intended to lead to the identification of suppliers that can demonstrate sufficient capability to provide these services in the best possible way and in a manner that enables Safaricom meet its expectations. The identified suppliers will be invited for a competitive tendering process from which the suppliers to be engaged will be identified.

Safaricom is therefore soliciting for Expressions of Interest from interested companies clearly showing the following:

- Years of experience as a provider of these services
- The principal place of business.
- Countries where the company provides the services.
- List of clients where the services have been offered in the past five years with reference contact details. This should include a brief summary of the scope and period.
- Three years audited accounts.
- Statutory Authority approval documents that are required for the provision of this service e.g. NCA, CA certificates etc.
- Any additional information that supports your capabilities in this scope.
