

# Expression of Interest - Provision of Audio-Visual Equipment Rental and Technical Set up Services

#### 1. INTRODUCTION

Safaricom is the leading integrated communication services provider in Kenya and has a steadily growing subscriber base. The company is continuously seeking for opportunities to maximize shareholder value.

Safaricom intends to appoint audio-visual and technical set up expert to work on Safaricom's events, sponsorships and related experiential marketing activities. The supplier will be expected to liaise closely with Safaricom and its agencies to successfully deliver Audio-Visual Equipment Rentals and Technical Set up Services in line with the approved event plans for Safaricom PLC. This includes the execution of in person and hybrid (in person + digital) event engagements. This document constitutes the formal call for the Expression of Interest (EOI) from experienced and reputable suppliers in the industry interested in providing Audio-Visual Equipment Rental and Technical Setup services to Safaricom and affiliates under the group.

### 2. AIMS AND OBJECTIVES

This Expression of Interest (EOI) document is intended to lead to the identification of experienced and reputable suppliers in the industry with demonstrable capacity and experience to provide Audio-Visual Equipment Rental and Technical Setup services for Safaricom events.

Safaricom is therefore soliciting from interested companies an Expression of Interest clearly demonstrating the evidence that your company has the right inventory levels of Audio-visual equipment rentals and the necessary technical know-how to undertake the services.

#### 3. SCOPE

If awarded the contract, the scope of this engagement shall be the **Provision of Audio-Visual Equipment Rentals and Technical Setup Services.** 

Key deliverables under this scope include;

- A. Provision of audio-visual services including equipment rentals and technical setup for web streaming, video conferencing, live broadcasts and events.
- B. Design and build of creative event stages, booths and engagement spaces in line with brand guidelines as per approved event plans. This includes working with the Safaricom Event Team to provide best practice advise on the optimum utilization of spaces
- C. Provision of visual event equipment including LED and Daylight Panel screens, projectors, LED / OLED Screens that will be used as per approved event plans. This includes relevant digital mixers to integrate screen equipment and manage content, as well as clickers for event presentations



- D. Provision of relevant sound equipment including but not limited to microphones (cordless, podium / goosenecks and lapel mics), indoor and outdoor speakers and sound systems and audio mixers for use at in person and hybrid events
- E. Provision of high definition (1080p and above) camera equipment and digital mixers to be used at hybrid / livestreamed events
- F. Provision of relevant crowd control equipment for outdoor events including crowd control barriers and trussing as per approved event plans and in collaboration with Safaricom's security teams
- G. Event production including staging, graphics and design services. Work closely with Safaricom's Event Agency to bring to life approved event plans and concepts, in accordance to brand guidelines
- H. Provision of backup generators for events to provide power independently of main electricity supply for all technical equipment on ground and other experiential spaces as per approved event plan
- I. Post Event reporting and documentation

For interested bidders please read through Step 1 and Step 2. Note that both are distinct processes to be reviewed by two different teams in Safaricom. In the interest of time, you are advised to work on both processes concurrently immediately you receive this EOI.
